Andrea Dobin, Chair of the firm's Bankruptcy/Creditors' Rights Practice Group, focuses her practice in bankruptcy and insolvency issues. She is a co-author of the section of the New Jersey Bankruptcy Manual, published by the New Jersey Institute for Continuing Legal Education in 2006, on "Representing Chapter 7 Trustees." Ms. Dobin's article, "Managing the Right of First Refusal of Co-Owners of Property in 11 U.S.C. Section 363(i)," was published in the Winter 2002/2003 issue of *NABTalk*, the magazine of the National Association of Bankruptcy Trustees.
